

# TOWN OF BELMONT WARRANT FOR 2019 SPECIAL TOWN MEETING MAY 1, 2019 COMMONWEALTH OF MASSACHUSETTS

To any of the Constables of the Town of Belmont in said County:

#### Greetings:

In the name of the Commonwealth of Massachusetts you are required to notify and warn the Inhabitants of the Town of Belmont, qualified as the law requires to vote in elections and Town Affairs, to meet at the Belmont High School Auditorium on **WEDNESDAY**, **MAY 1**, **2019**, **at 7:30 P.M**., and to notify and warn the Town Meeting Members to meet and act at said time and place on the following Articles:

#### **ARTICLE 1:**

### ADDITIONAL APPROPRIATION FOR POLICE STATION RENOVATION

To see if the Town will vote to borrow and/or appropriate a sum of money from available funds for the Police Station/DPW renovation project including all costs and related expenses, so that the Town Treasurer with the approval of the Board of Selectmen is authorized to borrow said sum of money under the provisions of Chapter 44, Section 7(1) or any other lawful authority.

This article will allocate an additional sum of money to the DPW/Belmont Police Department building project for work on the Police Station that was not in the original scope of the project when approved at the Special Town Meeting on November 13, 2017. The police will now vacate the facility to allow the interior of the original building to be renovated. The sum of money requested will cover the renovation work; the cost of relocating the Police, including renting trailers and all necessary technology adjustments. Bids will be opened on April 26<sup>th</sup>.

#### **ARTICLE 2:**

#### TRANSFER TO KENDALL FUND

To see if the Town will vote to appropriate a sum of money from various sources to replenish the Kendall Fund or in any way act thereon.

This article would authorize the transfer of the excess premiums from the sale of general obligation bonds in the total amount of \$3,662.96 to the Kendall Fund as follows: from the Belmont High School Project (\$868.89), from the Department of Public Works/ Police Station Project (\$837.35), from the Water (\$1,956.72), from the available balances of the Police and Department of Public Works Feasibility Studies \$237,159.24, and from the Wellington Building Project Fund \$232,000.

#### **ARTICLE 3:**

#### APPROPRIATION OF TRANSPORTATION GRANT

To see if the Town will vote to appropriate a sum of money received from the Commonwealth Transportation Infrastructure Fund for the purpose of funding improvements to the Town's transportation infrastructure, or take any action thereto.

This article is to appropriate monies received from the Commonwealth as the Town's share of the Transportation Infrastructure Enhancement Trust Fund. The Town has decided to use this money for engineering work to improve the Sycamore/Lexington intersection.

ARTICLE 4: PRIOR YEAR BILL

To see if the Town will vote to pay prior year bills by transferring from available funds, or to take any other action relative thereto.

This article seeks to appropriate a sum of **\$5,058.00** from available funds for payment of old bills in fiscal year 2017-2018. The bills represent payment owed for work performed at the Fire House, Homer Building, Police Station, and Town Hall.

# TOWN OF BELMONT 2019 SPECIAL TOWN MEETING MAY 1, 2019 COMMONWEALTH OF MASSACHUSETTS

ARTICLE 1: ADDITIONAL APPROPRIATION FOR DEPARTMENT OF PUBLIC WORKS AND POLICE STATION RENOVATION PROJECT

MOVED: That an additional \$3,756,494.24 be appropriated to design, construct, reconstruct,

renovate and equip the Department of Public Works and Police Station buildings, including site work and ancillary improvements, by (1) repurposing the balance of the amount appropriated for schematic level design under Article 4 of the November 13, 2017 Special Town Meeting in the amount of \$256,494.24, and (2) by borrowing the sum of \$3,500,000, and further to meet this appropriation the Town Treasurer, with the approval of the Board of Selectmen, is authorized to borrow a sum of \$3,500,000.00 under the

provisions of Chapter 44, Section 7(1) or any other lawful authority. (*Two-thirds vote*)

(The Building Committee will meet on Tuesday, April 30 to review the bids and determine the exact amount of extra funds that will be requested under Article 1 of the Special Town

Meeting.)

Reporting: The Board of Selectmen, Warrant Committee, Capital Budget Committee, and the

Building Committee.

ARTICLE 2: TRANSFER TO KENDALL FUND

**MOVED:** That the Wellington Building Project Fund be closed out and the available

remaining balance of \$232,000 be transferred to the Kendall Fund. (Majority vote)

**MOVED:** That \$3,662.96 of excess premiums from the sale of general obligation bonds be

transferred to the Kendall Fund as set forth under Article 2 in the Warrant for this

meeting. (Majority vote)

ARTICLE 3:

### Department of Public Works/Belmont Police Department Building Committee

Dear Town Meeting Members,

On Wednesday, May 1, 2019 the Department of Public Works/Belmont Police Department Building Committee will request additional funding through a Special Town Meeting article. An expansion of the original scope of the police station work necessitates this request.

We were very pleased that last year Town Meeting enthusiastically supported our request for \$7.4 million to renovate and construct additions to both the police and DPW facilities. That sum was obtained by a recent bond offering by the Town. The bonds will be paid off over time from the operating budget without the need for a debt exclusion.

The original plan we presented to you was to renovate the police station while the police remained in the building. There have been several developments since that time. First, it emerged that construction would be quicker, cheaper, and safer if we instead temporarily relocated police operations and vacated the building. Second, the Committee realized that vacating offered a one-time opportunity to address additional significant deficiencies in the interior spaces and systems of the existing building that were not in the original scope of work. Third, the cost estimates for certain portions of the original work have increased due to a hot construction market. The Committee has scrutinized these revised costs carefully and believes they are necessary and prudent.

Temporary relocation will require renting trailers to be placed at the Water Department site at the end of Woodland St. and a trailer on Concord Ave. for emergency dispatch. The trailers will have hook ups for utilities and technology. Stored documents and the gym equipment will move into the Town Hall auditorium. While we estimate that relocation could cost up to \$500,000, moving the police will result in a savings of between \$820,000 to \$1.0 million on the original construction estimate.

The factors just described have led the Committee to request an additional amount from the Town Meeting not to exceed \$3.5 million to be used mostly on the police station portion of the project. Funding for the additional \$200,550 in design work will be explained at Town Meeting. The Committee believes it is critical to update and bring up to code the entire building, making it ready to serve the Belmont Police Department for the next fifty years.

Separately, we urge you to support our request for \$787,575 from Community Preservation funds for repair and restoration of the historic exterior of the police station. We have asked the Capital Budget Committee for up to \$100,000 for furnishings, fixtures, and equipment

for the DPW in the FY20 budget. Please support this Capital Budget item. We expect to request the cost for furnishings, fixtures, and equipment for the police station in the FY21 Capital Budget.

Here are the latest cost estimates for the work described above:

\$100,000	Fixtures, furnishings and equipment for DPW from Capital Budget FY20
\$250,000	Fixtures, furnishings, equipment estimate for Police from Capital Budget FY21

Bids for the entire project will be opened on Friday, April 26. The Building Committee will meet on Tuesday, April 30 to review the bids and determine the exact amount of extra funds that we will request under Article 1 of the Special Town Meeting. The \$3.5 million figure currently in the article is a place holder. The actual amount will be presented to the Special Town Meeting and the article amended to reflect that amount.

We look forward to showing the Town Meeting our drawings and plans for both buildings and expect that you will be as excited as we are about this project.
