This matter came before the Board of Appeals ("Board") of the Town of Belmont ("Town") acting as Special Permit Granting Authority under the Zoning By-Law of the Town of Belmont, Massachusetts ("By-Law") and Chapter 40A of the Massachusetts General Law ("Zoning Act").

The Applicant sought three (3) Special Permits to construct what amounted to a building jacket to enclose a garage located in a General Residence (GR) Zoning District. The building jacket, having to completely enclose the garage, inevitably had a larger footprint. This had the effect of reducing side and rear setbacks as well as increasing lot coverage.

The purpose of the enclosure was similar to that of vinyl siding: to provide an aesthetically pleasing enclosure for a deteriorating high-maintenance structure. The building jacket was to incorporate some unusual features, notably integrated planters that would create the illusion of vegetation growing on the wall. This had the effect of mitigating the aesthetic impact of the reduced setbacks that accompanied the jacket's installation. The building jacket was also to include a drainage system to direct rain into rain barrels.

Construction would have the effect of increasing lot coverage from 30% to 37.8%, reducing side setback from 2 feet to only 1.4 feet, and reducing rear setback from 1.5 feet to 1 foot. In a GR district, the corresponding required values are 30%, 5 feet, and 5 feet respectively.

At the hearing, there was no opposition. One neighbor spoke in favor of the project notwithstanding the fact that its completion would cause his own garage to assume the role of least-attractive garage in the neighborhood.

After some deliberation, the Board deemed that the aesthetic appeal of a vegetated wall would mitigate the reduced setbacks sufficiently so that the overall character of the already densely-populated neighborhood would remain substantially unaffected. The increase in lot coverage was deemed insufficient to substantially alter the character of the neighborhood.
