For the past five years, my catering business has been located at 129 Belmont Street. My husband, children and I live close by in Arlington where I began my catering business in 2012. My business specializes in catering Afternoon Tea for events and parties. I prep baked goods and sandwiches on site and deliver them to locations around greater Boston. My business is my passion and I have loved being able to run my small company around my family schedule.

In the last five years, I have grown my catering company and also managed the retail bakery side of the store where I sell baked goods such as scones, teacakes and tea/coffee. My hope for my business in 2020 is to add seating to the retail side of the store – converting it from a takeout bakery to a fast food restaurant. Feedback we have received from our customers is that they would like a sit-down tearoom where traditional tea is served on proper plates and teacups. In addition to sit-down tea, we will also continue to have takeout baked goods and drinks to go. Our menu will remain the same as our current catering menu consisting of basic sandwiches mixes, soups, and baked goods. Our operating hours will be Tuesday-Sunday 9am to 5pm. I currently do not have any full time employees but hope to hire 1-2 part time employees with the special permit approval.

I would appreciate it very much if the board grants the special permit to operate a fast food business. We have loved being part of the Belmont community and look forward to continuing to serve our neighbors in the area.


