### Introduction

This matter came before the Board of Appeals ("Board") of the Town of Belmont ("Town") acting as Variance and Special Permit Granting Authority under the Zoning By-Law of the Town of Belmont, Massachusetts ("By-Law") and Chapter 40A of the Massachusetts General Law ("Zoning Act"). The Applicant LA VICTORIA TAQUERIA, Alejandro Barrienos, owner, requests one (1) SPECIAL PERMIT under Section 3.3 of the Zoning By-Laws to change the ownership of an existing Full Serve restaurant and to operate a Fast Food restaurant at 66 Leonard Street located in a Local Business I (LBI) Zoning District.

The Board held a duly noticed hearing on the application on November 9, 2020 conducted via ZOOM videoconference (in connection with current restrictions regarding social distancing in connection with COVID-19). The Applicant, Alejandro Barrienos, presented the proposal to the Board.

No one at the hearing spoke in favor of or in opposition to the Applicant's proposal.

#### **Proposal**

The applicant would like to transfer ownership of the El Centro, a Full Serve restaurant and operate a Fast Food restaurant. Operating a Fast Food Restaurant in LBI zoning district is allowed by a Special Permit granted by the Board of Appeals.

Mr. Alejandro Barrienos, owner of LA VICTORIA TAQUERIA owns two other locations, one in the Town of Arlington, Massachusetts and the other in the Town of Beverly, Massachusetts.

The current (El Centro) restaurant has an approval for 60 seat. Although Mr. Barrienos intends to reduce the number of seating, for the purpose of the Special Permit relief requested, he would like to maintain the approved 60 seat capacity.

The proposed hours of operation will be seven days a week between the hours of 11:00AM and 9:00PM. Daily provision deliveries will be scheduled between the hours of 6:00AM and 7:30AM. Weekly large

deliveries will be scheduled between the hours of 11:00AM and 3:00PM. The restaurant will use the trash dumpster provided by the Building Condo Association, no additional trash containers will be used.

The proposed Fast Food restaurant is in keeping with the character of the Belmont Center Local Business District and will not be detrimental to the community.

#### Conclusion

On November 9, 2020, the Board deliberated on The Applicant's, LA VICTORIA TAQUERIA, Alejandro Barrienos' ("Applicant") request for One (1) Special Permit under Section 3.3 of the Zoning By-Law to operate a fast Food restaurant at 66 Leonard Street located in a Local Business I (LBI) Zoning District.

The Board determined that the proposed restaurant does not pose any substantial detriment to the neighborhood, does not nullify or derogate the intent of the By-Law and will benefit the Town.

Accordingly, upon motion duly made by Nick Iannuzzi and seconded by James Zarkadas, the Board voted 5-0 to grant the Applicant the requested (1) Special Permit subject to the following conditions:

- 1. Hours of operation will be seven days a week between the hours of 11:00AM and 9:00PM.
- 2. Daily provision deliveries will be between the hours of 6:00AM and 7:30AM.
- 3. Weekly deliveries will be between the hours of 11:00AM and 3:00PM.
- 4. Seating capacity shall not exceed 60 as shown on the plans submitted to the Board.
